- g. Move the "Spill or Leak" section out of the Storage and Disposal box.
- h. Change the Pesticide Disposal statement to read "Wastes resulting from the use of this product **must** be disposed of on site or at an approved waste disposal facility."
- i. Change the Container Disposal statement in accordance with PR Notice 2007-4.


