The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Bifenthrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Do not apply more than 484 pounds of Bifenthrin 0.083 Insecticide with X-X-X Fertilizer per acre per year.

For soil or foliar applications, do not apply by ground within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and commercial fish farm ponds.

Do not apply the product into fish pools, ponds, streams, or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur.

Do not allow the product to enter any drain during or after application.

Do not apply directly to impervious horizontal surfaces such as sidewalks, driveways, and patios except as a spot or crack-and-crevice treatment.

Do not apply or irrigate to the point of runoff.

LAWN AND PERIMETER APPLICATIONS

Perimeter Application: Apply 2.75 to 5.5 pounds per 1,000 sq. ft. to ground areas 6 to 10 feet wide around and adjacent to the structure.

Lawn Application: Apply Bifenthrin 0.083 Insecticide with X-X-X Fertilizer with suitable broadcast application equipment to ensure uniform coverage over the treated area. Apply 2.75 to 5.5 pounds per 1,000 sq. ft. to control the following insect pests:

In New York State, do make a single repeat application of Bifenthrin 0.083 Insecticide with X-X-X Fertilizer if there are signs of renewed insect activity, but not sooner than two weeks after the first application.
