The labeling referred to above, submitted under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended to voluntarily delete uses on carrots and peanuts is acceptable. The cover letter dated 7/19/12 submitted with your application indicated that you voluntarily waived the 180 day comment period, resulting in a 30 day comment period. This comment period closed 2/1/13 and no comments were received. The Federal Register notice of this use deletion dated 1/2/13, explains the existing stocks provisions for this approval.

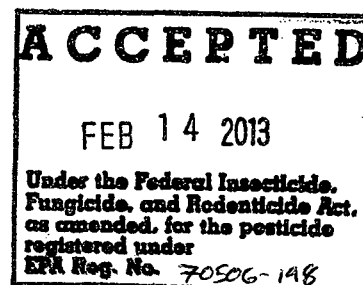
