Alkaline materials such as spray lime, lime-sulfur and bordeaux mixture will reduce the fungicidal activity of captan. Do not apply captan in combination with or immediately before or closely following oil sprays. The time factor governing the safe interval between captan and oil sprays varies due to general climatic conditions; therefore, consult local agricultural spray programs and authorities to determine the proper timing. The use of spreaders which cause excessive wetting is not advised. Combinations with solvent formulations of organic phosphates should not be used.
