On the basis of information furnished by the registrant, the above named pesticide is hereby registered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. This product is conditionally registered in accordance with FIFRA §3(c)(7)(a) provided that:

- 1. This registration is time-limited and expires two years from the date this product is first released for shipment.
 - You must provide the Agency with a projected release for shipment date within 30 days of the date of this Notice of Registration. The Agency will calculate the expiration date based on the projected release for shipment date until an actual release for shipment date is provided in writing.

- 6. On page 1 under Mosquitoes, revise the claims (delete struck-out text and/or add underlined words) to read as follows:
 - "[[Kills mosquitoes] [within 24 hours] [kills mosquitoes that may transmit heartworm] [within 24 hours for up to the first 7 days after treatment, and within 48 hours for up to 28 days]]."
- 7. On page 1 under Adult Fleas, delete revise the claims (delete struck-out text and/or add underlined words) to read as follows:
 - "[Kills fleas, a source of flea allergy dermatitis] [, flea bite anemia] [and] {, tapeworm infestations]"
 - "[If cat is a high risk for flea reinfestation, apply once a month application may be needed]"
- 8. On page 1 under Ticks, revise the claims (delete struck-out text and/or add underlined words) to read as follows:
 - "[Kills-[all-stages of] deer ticks [that may carry transmit Lyme disease,] [before they can transmit Lyme disease] for up to [[4] [four] weeks] [1 months] [30 days]"
 - "[Kills ticks [before they can transmit disease]]"
- 9. On pages 1 and 2 under Multiple Infestations, revise the claims (delete struck-out text and/or add

underlined words) to read as follows:

- "Monthly [flea], [tick], [mosquito], and [chewing lice] {protection} [treatment]"
- "[Four] [Three] [4] [3] Way [Action] [Control] Protection, [kills [fleas], [ticks], [mosquitoes], [chewing lice]]"
- "[Four (4) [-] Week] [1 month] [30 day] [Flea], [Tick], [Mosquito], and [Chewing Lice] control]"
- "[Monthly [flea], [tick], [mosquito] and [chewing lice] protection.]"

- 10. On page 2 under All Others, revise the claims (delete struck-out text and/or add underlined words) to read as follows:

 - "[For cats and kittens [8 weeks old and older] [more than 8 weeks old]]"
 - "[Controls mites that may cause sarcoptic mange [infestations]]"
 - "[Once-a-month treatment recommended]"
 - "[A once monthly application is recommended for chewing lice]"
 - "[Three applications {for cartons with 3 applicators}] and/or [3-month supply] or [12-week supply] or [{3} applications]"
 - "[(Icon showing 4-week protection)]"
 - "[Fast-acting, long-lasting protection that's also waterproof.]"
 - "[[Free] brochure inside!]"
 - "[[Free] brochure and calendar stickers inside]"
 - "[Can be used on kittens-[8 weeks of age and older] [more than 8 weeks of age]]"

- 11. On page 3 under the Caution, delete "[or] [insert]" because this has not been submitted to the Agency for review and approval.
- 12. On page 3 under the Net Contents, <u>delete</u> the following statement:
 - "This product features a sustained-release formula that discharges from the animal's hair follicles using the natural skin oils, resulting in fast-acting [and long-lasting] control of [fleas], [ticks], [mosquitoes] and [chewing lice] [for 30 days]."
- 13. On page 3 under Read Entire Label Before Each Use, revise the paragraph to read as follows:
 - [NAH 1] for cats provides [four-] [three-] way protection that kills [fleas], [ticks], [mosquitoes] and [chewing lice]. Controls mites that may cause sarcoptic mange [infestations]. Kills deer ticks [that may transmit Lyme disease] [before they can transmit disease]. Kills brown dog ticks, American dog ticks and lone star ticks. Prevents flea reinfestation.]
- 14. On page 4, delete "[and enclosed directions]" from the Directions for Use because this insert has not been submitted to the Agency for review.
- 15. On pages 4 and 6 under How to Apply, delete "[0.017 fl oz] [0.50 mL]" so that the use directions are more clear by stating "one tube..." per application.
- 16. On page 5 under the How to Apply instructions continued from page 4, replace "[4] [four] weeks"

with "30 days" to be consistent with the Frequency of Application information.

17. On page 5 under Frequency of Application, revise the fourth statement to read as follows:

"NAH 1 kills mosquitoes within 24 hours for up to the first 7 days after treatment, then within 48 hours for up to 28 days.]"

- 18. On pages 5, 6, and 8, delete "insert copy" because this insert has not been submitted to the Agency for review.
- 19. With respect to referenced optional web-address additions to the product label, please be advised that referenced web pages or URLs associated with this product are also subject to review and approval by the Agency.
- 20. On page 7, delete "Actual graphics may differ slightly" from the last claim, as this must be submitted to the Agency for review and approval prior to production.
- 21. On page 8, delete the graphics that show the person's arms cutting the package, or applying the product on the cat's back because these images were not originally submitted for approval when the Agency completed their review for child-resistant packaging.
- 22. Be advised that regarding the text to be printed on the front of the tube, the net weight must be expressed in English units, i.e., "0.017 fl oz." Metric units may be expressed in addition to (adjacent) to the English unit weight expression.
- 23. Revise the EPA Registration Number to read: "EPA Registration No. 70585-11."

If the Agency determines that future mitigation measures are necessary for all pet spot-on products, you will be informed, and be expected to comply. If mitigation measures are necessary, the Agency may take appropriate regulatory actions. Two copies of the finished labeling must be submitted prior to releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions. A copy of your label stamped "Accepted with Comments" is enclosed for your records. 




