

## **SHAKE BEFORE USING**

**General Use Directions:** (To Spray:) Hold container upright. Point valve opening away from face and press button, keeping at least 3 feet from interior walls, fabrics, furniture and plants. Spraying closer may cause stains or may damage certain floors or plastics. Leave treated area after spraying. Keep room closed for 15 minutes. Ventilate upon return.

**To Kill Flying Insects:** flies, mosquitoes, flying moths, gnats, wasps. With this product there is no need to spray directly at flying insects - the mist in the air will kill them. Close all doors and windows. Spray this product up into the air with a sweeping motion.

**To Kill Crawling Insects:** roaches, waterbugs, silverfish, crickets. Spray hiding places such as baseboards and floorboards, moist places, openings around sinks, drains and pipes, behind bookcases, cabinets and other storage areas. Repeat as needed.

**To Kill Ants:** Spray trails, hills, around windows and sills and openings around pipes and baseboards where ants crawl. Repeat as needed.

**To Kill Spiders, Centipedes, Sow Bugs:** Spray webs and places where these pests crawl. Repeat as needed.

**To Kill Carpet Beetles:** Hit these bugs directly with spray on sections of floor, baseboards, shelves and carpets. Repeat spraying at frequent intervals.

**To Kill Bedbugs:** Spray baseboards, moldings, floor boards. Spray mattresses, particularly around seams and tufts. Take beds apart and spray all joints. Repeat spraying at frequent intervals.

**To Kill Fleas:** Spray floors, floor coverings and sleeping quarters of pet. Repeat spraying as often as necessary. Do not spray pets.

**For Use in Food Processing Areas:** The use of this product in food processing plants should be confined to time periods when the plant is not in operation. Foods should be removed, covered or stored in closed containers. Facilities and equipment must be thoroughly washed with an effective cleaning compound and rinsed with potable water after spraying.
