#### **DIRECTIONS FOR USE**

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

BIOKRYL I is a bacteriostatic agent that is effective against non-health related organisms which may contribute to the deterioration of end-use products. Use of BIOKRYL I extends the useful life of treated articles and controls odors resulting from non-health related organisms on treated articles.

- Use only under an agreement with Courtaulds European Fibers Inc.
- Do not use for the production of baby diapers or fibers for the production of baby diapers.
- Do not use for the production of health care products or products intended to decrease the transmission of disease.

#### **ENGINEERING CONTROLS**

Procedures should be established to minimize dusting. Open container and weigh product under a dust hood that reduces dust to less than 50 micrograms per cubic meter. During mixing procedures, use engineering controls to reduce product dust to less than 50 micrograms per cubic meter in the surrounding atmosphere.

### PREPARATION OF 10% (W/W) RESIN CONCENTRATE

- 1. Place resin pellets in a mixing drum.
- 2. Add mineral oil and rotate drum until pellets are coated with mineral oil.
- 3. Slowly and carefully add BIOKRYL I into the mixing drum while avoiding dusting.
- 4. Close mixing drum.
- 5. Rotate mixing drum until pellets are coated.
- 6. Melt the coated pellets.
- 7. Extrude and re-pelletize melted resin.
- 8. Label concentrate using labels provided exclusively by Courtaulds European Fibers Inc.

## PREPARATION OF FILMS, YARNS, FIBERS AND MOLDED PRODUCTS FOR SPECIFIED USES

Operators should wear protective gloves and respirators.

- Add a measured quantity of base resin to a mixing tank.
- Add a measured quantity of 10% RESIN CONCENTRATE to the mixing tank to achieve the desired active ingredient concentration in the finished product. The desired concentration will depend upon the nature of the product and the desired duration of bacteriostatic activity.
- 3. Melt the contents of the mixing tank and stir contents until uniformly blended.
- 4. Extrude film, yarn or fiber or fill molds for molded finished products.
- 5. Label finished products with labels provided exclusively by Courtaulds European Fibers Inc.
