DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product may be used for formulating end-use repellent products registered with EPA by the formulator for use against mosquitoes, deer ticks, body lice, and biting flies. This product may be used to formulate products for any additional use(s) not listed on the label if the formulator has complied with U.S. EPA submission requirements regarding support of such use(s).

Water- and alcohol-based formulations may be prepared by addition of various agents, to increase viscosity, prior to addition of water-insoluble IR3535®. Mixtures may be heated to 75°C and then cooled to promote development of stable suspensions. Inert ingredients may be added at various times during the process depending upon whether they are water soluble or insoluble.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

PESTICIDE STORAGE: Store in a dry place away from extreme heat and cold (tightly closed at or below 59-77°F or 15-25°C). Keep container closed when not in use. In the event of spillage or leakage, soak up material with absorbent clay, sand, sawdust, or other absorbent material. Scrape up and dispose of in accordance with information given under PESTICIDE DISPOSAL section below. In case of fire or other emergency, contact Chemtrec Emergency (800-424-9300).

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of at an approved waste disposal facility.

CONTAINER HANDLING:

[Nonrefillable containers up to 55 gallons in size.]

Nonrefillable container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows. Empty the remaining contents into application equipment or a mix tank. Fill the container [$\frac{1}{4}$] [one quarter] [25

percent] [1 / 4] full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling or reconditioning, if available. Or puncture and dispose of in a sanitary landfill or by other procedures allowed by state and local authorities.

[Non-refillable containers with capacities greater than 55 gallons]

Non-refillable Containers –Pressure rinse container promptly after emptying. To pressure rinse the container, empty the remaining contents from the IBC into application equipment or mix tank. Raise the bottom of the IBC by 2 inches on the side which is opposite of the bottom discharge valve to promote more complete product removal. Completely remove the top lid of the IBC. Pressure wash with water to rinse all interior portions. Continuously pump or drain rinsate into application equipment or rinsate collection system while pressure rinsing. Continue pressure rinsing for 2 minutes or until rinse becomes clear. Replace the lid and close bottom valve. Once container is rinsed, offer for recycling if available or puncture and dispose of in a sanitary landfill.
