Bait Use Apply balEnceTMBeetle Bait under feed lines and feed pans at a rate of 1 oz per sq. foot using a drop spreader or hand shaker with a maximum use of 12 to 24 lbs of balEnceTMBeetle Bait per house. Application should be made prior to bird placement. Re-treatment maybe necessary if darkling beetle numbers are high at the start of a flock and should be done in 4 week intervals. The product is only to be applied to poultry or livestock manure that is to be composted.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store in a cool, dry place in original container and out of direct sunlight. Do not store at temperatures exceeding 80 ° F (27° C).

PESTICIDE DISPOSAL: To avoid wastes, use all material in this container by application according to the label directions.
