

The nominal concentration of the active ingredient given in the Basic Formulation CSF agreed with the percentage declared on the label. The revised CSF is acceptable provided that you provide the source of the water in item 11 of the CSF e.g. municipal water, well water, deionized water etc. A copy has been inserted in your file for the subject product.



Submit two copies of your final printed labeling before you release the product for shipment.

It is understood that the new basic CSF dated May 26, 2000 will supersede the previously accepted one.
