Dear Ms. Kasprisin:

The following amendment, submitted in connection with registration under section of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with comments:

**Proposed Amendment:**

- revise first aid statement PR Notice 2001-1

**General Comment:**

Based on the me-to product associated with this registration (reg. No.1839-84) the change in signal word to Warning is acceptable.

1. Revise the Precautionary Statement as follows:

"Causes substantial but temporary eye injury and skin irritation. Do not get in eyes on skin or on clothing. Wear protective eyewear, clothing and gloves. Wash thoroughly with soap and water after handling and before eating, drinking, or using tobacco. Remove contaminated clothing and wash before reuse".

2. Revise the following phrase: "is also fungicidal against Pathogenic fungi (*Trichophyton* 'Mentagrophytes) (when used as directed on *non-porous* hard surfaces found in the bathroom, shower stall....."

**DIRECTIONS FOR USE:** It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. This product is not to be used as a terminal sterilant/high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to pre-clean or decontaminate critical or semi-critical medical devices prior to sterilization or high level disinfection. State FIX "Terg-o-Cide in a Can" is designed for cleaning and disinfecting in hospitals, nursing homes, schools, offices, motels and hotels. When used as directed, it is formulated to disinfect inanimate hard surfaces (such as walls, sink tops, tables, chairs, telephones, bathrooms, shower stalls, bath tubs, hampers, cabinets and bed-springs).

In addition, State FIX "Terg-o-Cide in a Can" deodorizes those areas generally hard to keep fresh smelling (such as garbage bins, basements, restrooms, and other areas which are prone to odors caused by micro-organisms). Contains no CFC's or other ozone depleting substances. Federal regulations prohibit CFC propellants in aerosols. **DISINFECTION, DEODORIZATION AND CLEANING:** To disinfect hard nonporous surfaces proceed as indicated below:

(1) Shake can before using. (2) Hold six to eight inches from surface to be sprayed. (3) Spray area until it is covered with white foam. Allow foam to penetrate and remain wet for 10 minutes. No scrubbing necessary. (4) Wipe off with a clean cloth, mop or sponge. State FIX "Terg-o-Cide in a Can" will not leave grit or soap scum. For heavily soiled areas, remove gross soil before treatment.

**SPECIAL INSTRUCTIONS FOR CLEANING AND DECONTAMINATING AGAINST HIV-1 (AIDS VIRUS) OF SURFACES / OBJECTS SOILED WITH BLOOD / BODY FLUIDS:** The product kills HIV-1 (AIDS Virus) in hospitals and other health care facilities in which there is an expected likelihood of soiling of inanimate surfaces with blood or body fluids, and in which the surfaces likely to be soiled with blood or body fluids can be associated with the potential for transmission of HIV-1 (AIDS Virus).

**PERSONAL PROTECTION:** Wear barrier protection such as latex gloves, gowns, masks or eye coverings when handling items soiled with blood or body fluids.

**CLEANING PROCEDURE:** Blood and other body fluids must be thoroughly cleaned from surfaces and objects before application of State FIX "Terg-o-Cide in a Can".

**CONTACT TIME:** Follow disinfecting instructions listed above. Allow the product to penetrate and remain wet for 10 minutes before wiping off.

**DISPOSAL OF INFECTIOUS MATERIALS:** Blood and other body fluids should be autoclaved and disposed of according to local regulations for infectious waste disposal. When used as directed, State FIX "Terg-o-Cide in a Can" demonstrates effective disinfection against *Staphylococcus aureus*, *Salmonella choleraesuis*, and *Pseudomonas aeruginosa*, thus meeting the requirements for hospital use. It is an effective one-step cleaner disinfectant in the presence of organic soil (5% blood serum).

State FIX "Terg-o-Cide in a Can" is also fungicidal against Pathogenic fungi (Trichophyton mentagrophytes) when used as directed on non-porous hard surfaces found in the bathroom, shower stall, and locker room or other clean, hard, nonporous surfaces commonly contacted by bare feet. State FIX "Terg-o-Cide in a Can" is also virucidal against Herpes simplex Type 2 when used as directed on hard, non-porous, inanimate, environmental surfaces. State FIX "Terg-o-Cide in a Can" also kills HIV-1 (AIDS Virus) on pre-cleaned environmental surfaces / objects previously soiled with blood / body fluids.

**MILDEWSTAT:** To control mold and mildew on pre-cleaned, hard, nonporous surfaces (such as floors, walls, table tops) spray surfaces to be treated making sure to wet completely. Let air dry. Repeat application at weekly intervals or when mildew growth reappears.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center for treatment advice.

**If swallowed:** Call a poison control center or doctor immediately for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

**NOTE TO PHYSICIAN:** Probable mucosal damage may contraindicate the use of gastric lavage.
