Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identify the batch of the pesticide distributed and sold be placed on nonrefillable containers. The code may appear either on the label (and can be added by non-notification/PR Notice 98-10) or durably marked on the container itself.

Dear Sir or Madam:

On behalf of KIM-C1, LLC enclosed in a notification of label change per PR-Notice 2007-4. This notification is consistent with the guidance in PR Notice 2007-4 and the requirements of EPA's regulations at 40 CFR 156.10, 156.140, 156.144, 156.146, and 156.156. No other changes have been made to the labeling or the Confidential Statement of Formula for this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if the amended label is not consistent with the requirements of 40 CFR 156.10, 156.140, 156.144, 156.146, and 156.156, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.

The KT-30 Technical product is a dry material packaged in a plastic bag inside a rigid box. Appropriate storage and disposal non-refillable wording without residue removal instructions has been added to the label as required by PR-Notice 2007-4.

The KT-30 Plant Growth Regulator product is a 100% repack of the technical product, however the PGR end use material is mixed with a liquid in the field (per label instructions) to create a dissolved end use product prior to mixing with water for application. So technically the storage and disposal container rinsate directions would be for a liquid product, not a dry solid. On this basis the standard EPA wording for a non-refillable liquid product has been added to the KT-30 PGR label.
