#### GENERAL INFORMATION

Several important factors should be taken into account to achieve a high efficiency of selective weed control with RICESHOTS. These include uniform application, growth stage and weather conditions. To assure uniform application, shake or roll container prior to opening and mix the prescribed amount of product with a sufficient volume of carrier to provide thorough coverage of target area. For aerial application use approximately 10 gallons, and for surface (ground) applications 20-30 gallons of carrier per acre at high enough pressure. Agitate tank mixes thoroughly and continuously. Growth stage of weeds is very important. Best results for selective weed control are obtained when most grasses have reached the 1 to 3-leaf stage.
