• Born with both male and female sex organs, any two slugs or snails can breed.

• Since slugs and snails are nocturnal feeders, apply OR-CAL Slug & Snail Pellets late in the day.

• Slugs and snails can rehydrate themselves in damp conditions, which slows the killing action of bait.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Not for use on plants being grown for sale or other commercial use, or for commercial seed production, or for research purposes. For use on plants intended for aesthetic purposes or climatic modification and being grown in interior plantscapes, ornamental gardens or parks, or golf courses or lawns and grounds.

To control snails and slugs on the following vegetable and fruit crops, apply to soil surface around plants and trees. Do not contaminate edible parts of foliage.

Garden Areas: Toss these dry pellets throughout the entire garden, especially around bedding plants and other low-growing plants where slugs and snails may congregate. If ground to be baited is dry, sprinkle until wet before applying. To avoid damage to your garden, start applying these pellets before snails and slugs begin to appear at the beginning of the spring planting season. Repeat at 3-week intervals, or as necessary.

Fruit Crops: Apples, apricots, cherries, grapes, peaches, pears, nectarines, plums, avocados, blackberries, boysenberries, citrus, loganberries, raspberries, and strawberries

Vegetables: Asparagus, beans, blackeyed peas, broccoli, Brussels sprouts, cabbage, melons, carrots, cauliflower, corn, cucumbers, eggplants, endive, garlic, kale, kohlrabi, horseradish, lettuce, leeks, okra, onions, peas, peppers, potatoes, pumpkins, radishes, rutabagas, salsify, shallots, spinach, squash (summer and winter), swiss chard, tomatoes, and turnips.

For Snails and Slugs in Dichondra, Clover, and Grass Lawns: Distribute pellets over entire lawn as necessary. One pound will cover 800 to 1,500 sq. ft.
