intended for aesthetic purposes or climatic modification and being grown in interior plant scapes, ornamental gardens or parks, or golf courses or lawns and grounds.

To control snails and slugs on the following vegetables and fruit crops, apply to soil surfaces around plant and trees. Do not contaminate edible parts of foliage.

USAGE: For garden areas, fruit crops and vegetables, apply 5 to 7 pellets per sa. ft. or 1 lb. per 4,400 sa. ft.

GARDEN AREAS: Apply around bedding plants and other low-growing plants where slugs and snails may congregate. If ground to be baited is dry, sprinkle until wet before applying. To avoid damage to your garden, start applying these pellets before snails and slugs begin to appear at the beginning of the spring planting season. Repeat at 3 to 4 week intervals, or as necessary.

FRUIT CROPS: Apples, apricots, cherries, grapes, peaches, pears, nectarines, plum, avocados, blackberries, boysenberries, citrus, loganberries, raspberries, and strawberries.

VEGETABLES: Asparagus, beans, blackeyed peas, broccoli, brussel sprouts, cabbage, melons, carrots, cauliflower, corn, cucumbers, eggplants, endive, garlic, kale, kohlrabi, horseradish, lettuce, leeks, okra, onions, peas, peppers, potatoes, pumpkins, radishes, rutabagas, salsify, shallots, spinach, squash (summer and winter), swiss chard, tomatoes, turnips.

FOR SNAILS AND SLUGS IN DICHONDRA, CLOVER AND GRASS LAWNS: Apply 14 pellets per sq. ft. or one pound will cover 1,800 sq. ft.
