DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

ALGAECIDE:

To be used in swimming pools to control green, blue-green and yellow algae.

Remove filth such as leaves, branches and heavy algae growth.

SHOCK TREATMENT MAY BE NECESSARY BEFORE ORBS ARE USED.

Add 2 ounces per 5000 gallons of water. SEE CHART BELOW FOR CORRESPONDING ORB FOR POOL SIZE.

Remove orb from package. Place into skimmer basket. Allow 8 hours before reentering pool.

Maintain at 1-2 PPM at all times. (ONE ORB SHOULD LAST ONE SEASON-ABOUT THREE MONTHS. However factors such as water hardness, temperature, flow rate, amount of algae present, type of algae present may have an impact on the ppm level in the pool

NOTE: TREATED WATER SHOULD NOT EXCEED 4 PPM COPPER SULFATE PENTAHYDRATE.

CHART FOR POOL SIZES:

5,000 TO 10,000 GALLONS - 1 BLUE ORB (2 to 5 ounces) 10,000 TO 15,000 GALLONS - 1 GREEN ORB (5 to 8 ounces) 15,000 TO 20,000 GALLONS - 1 ORANGE ORB (8 to 10 ounces)
