Dear Dr. Beaulieu:

The amendments referred to above submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) section 3(c)(5), are acceptable provided that you:

- 1) Submit and/or cite all data required for registration/re-registration of your products under FIFRA section 3(c)(5) when the Agency requires all registrants of similar products to submit such data.
