

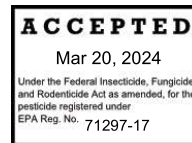

Harvista is a specialized formulation of 1-MCP (Methylcyclopropene) used to counteract the undesirable effects of ethylene on a wide range of crops. Benefits may include:

- Delayed ripening and associated benefits
- Management of harvest timing
- Increased retention of fruit firmness
- Increased yields and fruit size
- Reduced pre-harvest fruit drop
- Reduced ethylene production
- Improved color development
- Maintenance of fruit firmness and acid levels
- Increase in soluble solids
- Delayed starch hydrolysis
- Delayed onset and incidence of watercore
- Enhanced storage potential
- Enhanced fruit set

PRECAUTIONARY STATEMENTS

Plant Safety: This product has been tested on numerous plant varieties with no phytotoxic effects. However, since this product has not been tested on all plant varieties or in combination with all available adjuvants or tank mixes, the manufacturer recommends testing on a small number of plants to check for adverse plant effects before applying on a larger number of plants.

Incompatibility: Do not mix or allow contact with products containing copper.

GROUND APPLICATION

AF-701 must be applied using either an inline co-injection system or as a tank mix with an approved Cycloamylose adjuvant such as Havista Mix AF14050.

In-line co-injection application

AF-701 can be applied from a separate nurse tank through an in-line injection into the water spray line of a conventional spray equipment. Applicators should follow the use rate recommendations in the table given above for a specific crop. The co-injected water spray volume should be at least 2 gal/ac and as high as needed for desired application performance. Tank mix adjuvants such as surfactants and spray oils may be added into the water tank for better wetting, spreading, or other desirable results. Other agricultural products may be added into the water tank as co-application partners for convenience and time saving, but an AgroFresh authorized professional must be consulted to ensure there are no compatibility issues.

Tank mix spray application

Alternatively, AF-701 can be applied as an aqueous tank mix product by a conventional spray equipment using **an approved Cycloamylose adjuvant or equivalent such as Havista Mix AF14050.** AF14050 must be used at a minimum of 5% by weight of the spray water to ensure the spray stability and performance. An example of spray solution preparation procedure may include: 1) add water into the spray tank in the amount of ~80% of the final spray volume; 2) add AF14050 into the tank at a rate of 41.7 lbs per 100 gal water in the final spray volume, and mix till no solid visible; 3) add AF-701 at the use rate recommended in the table above; 4) top off with addition water needed to make the final spray volume. The spray volume should be at least 5 gal/ac and is recommended to be as low as practical for better efficiency and productivity. Tank mix adjuvants such as surfactants and spray oils may be added into the tank prior to the addition of AF-701 for better wetting, spreading, or other desirable results. Other agricultural products may also be added into the tank prior to the addition of AF-701 as co-application partners for convenience and time saving, but an AgroFresh authorized professional must be consulted to ensure there are no compatibility issues.

AERIAL AND DRONE APPLICATION

AF-701 must be applied using either an inline co-injection system or as a tank mix with an approved Cycloamylose adjuvant such as Havista Mix AF14050.

Spray at a height of fifteen (15) feet or less above the tree canopy unless a greater height is required for safety.

Nozzles must always point down, perpendicular to the ground.

In-line co-injection application

AF-701 can be applied from a separate nurse tank through an in-line injection into the water spray line of a typical aerial or drone spray equipment. Applicators should follow the use rate recommendations in the table given above for a specific crop. The co-injected water spray volume should be at least 2 gal/ac and up to 20 gal/ac. Tank mix adjuvants such as surfactants and spray oils may be added into the water tank for better wetting, spreading, or other desirable results. Other agricultural products may be added into the water tank as co-application partners for convenience and time saving, but an AgroFresh authorized professional must be consulted to ensure there are no compatibility issues.

Tank mix spray application

Alternatively, AF-701 can be applied as an aqueous tank mix product by a typical aerial or drone spray equipment using adjuvant, AF14050. AF14050 must be used at a minimum of 5% by weight of the spray water to ensure the

spray stability and performance. An example of spray solution preparation procedure may include: 1) add water into the spray tank in the amount of ~80% of the final spray volume; 2) add AF14050 into the tank at a rate of 41.7 lbs per 100 gal water in the final spray volume, and mix till no solid visible; 3) add AF-701 at the use rate recommended in the table above; 4) top off with addition water needed to make the final spray volume. The spray volume should be at least 5 gal/ac and is recommended to be as low as practical for better efficiency and productivity. Tank mix adjuvants such as surfactants and spray oils may be added into the tank prior to the addition of AF-701 for better wetting, spreading, or other desirable results. Other agricultural products may also be added into the tank prior to the addition of AF-701 as co-application partners for convenience and time saving, but an AgroFresh authorized professional must be consulted to ensure there are no compatibility issues.

IMPORTANT CONSIDERATIONS FOR USE OF AF-701

- Do not apply when temperatures exceed 95 degrees.
- Do not use overhead mist cooling or irrigation equipment for at least 1 hour following application.
- Do not apply if rain is expected within 1 hour of application.
- Combination effects and potential interactions between AF-701 and products containing ethephon have not been thoroughly evaluated. Use of these products on crops previously treated with AF-701 may reduce the benefits provided by AF-701 at harvest or after storage.
- Do not apply in winds exceeding 10mph
- Do not allow product to contact any copper or mix with products containing copper.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store in original packaging in a cool, dry place.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Handling: Nonrefillable container. Do not reuse or refill container smaller than 2 (two) gallons. Offer for recycling, if available.

For non refillable container, triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container $\frac{1}{4}$ full with concentrated salt water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure a second time with salt water and a third time with water.

For containers greater than 50 lbs: Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container $\frac{1}{4}$ full with concentrated salt water. Replace and tighten closures. Tip container on its side and roll it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure a second time with salt water and a third time with water.

Then offer for recycling if available, or puncture and dispose of in a sanitary landfill or by incineration. Do not burn unless allowed by the State and local ordinances.
