Revise the label as follows:

1.) According to PR Notice 83-3 and Label Review Manual, every product label must have "pesticide storage" instructions that inform the user how to store the product after use. Therefore, add the following to the "Storage and Disposal" section after the "Prohibitions:"

## Pesticide Storage:

2.) The "Directions for Use" must be brought into compliance with PR Notice 2000-5, Mandatory Labeling, by deleting the terms, "recommended" and "should." Replace should with the term, "must."

#### **HAZARDS TO HUMANS & DOMESTIC ANIMALS**

#### DANGER

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Sinesto B is a concentrate of quaternary ammonium salts in water for use only at lumber mills as an anti-sapstain treatment on freshly cut lumber.

Sinesto B will prevent sapstain, mold and mildew stains (blue stain) during storage and transportation of lumber and its use is not intended or expected to extend to the use site. It is suitable for dilution with water and subsequent application on freshly cut lumber. Application of the dilute solution may be by dipping or spraying. The wood should be treated within 24 hours after cutting.

Wear rubber gloves or equivalent protection when handling solution and freshly treated lumber.

Sinesto B should be diluted with between 10 and 30 parts of water, by volume, depending on the severity of the stain problem. Avoid vigorous stirring to minimize foam formation. A board test is recommended in order to define the optimum dilution ratio. The contact time should be at least 30 seconds. Treated wood should be held for 48 hours after treatment and must be protected against inclement weather. Dip tanks and drip aprons must be roofed, paved (or equivalent) and drained to prevent dilution and loss of the anti-sapstain solution. All equipment relative to the application of the sapstain should be properly maintained.

Treated sawdust and other wood wastes must be disposed of properly.
