1. OPPTS 850.1790 – Whole Sediment: Chronic Toxicity invertebrates freshwater and marine

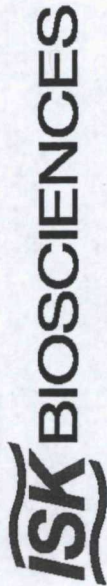
