Dear Mr. Kieniksman:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

### **THIS PRODUCT IS FOR MANUFACTURING AND REPACKAGING USE ONLY.**

Only for formulation or repackaging into insecticides for use in commercial greenhouses, interior plantscapes, nursery and landscape ornamentals, cotton, cucurbit vegetables, fruiting vegetables, leafy vegetables, potato, pome fruit, stone fruit, tree nuts, citrus, greenhouse peppers, greenhouse cucumbers and tomatoes, low growing berries, canola, legume vegetables (succulent or dried) except soybeans, alfalfa and clover grown for seed, and mint. This product may be used to formulate products for any additional uses not listed on this label if the formulator, user group, or grower has complied with USEPA data submission requirements regarding support of such uses.

## **STORAGE AND DISPOSAL**

---

DO NOT contaminate water, food or feed by storage or disposal. Open dumping is prohibited.

**STORAGE:** Store in tightly closed original container, in a cool, dry (preferably locked) area that is separate from other pesticides, fertilizer, food, and feed.

**PESTICIDE DISPOSAL:** Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal law.
