

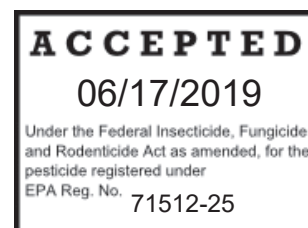

STORAGE AND DISPOSAL
