Dear Mr. Kieniksmann:

The application referred to above, submitted under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable under FIFRA section 3(c)(5).

You must submit and/or cite all data required for registration/reregistration/registration review of your product when the Agency requires all registrants of similar products to submit such data.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one (1) copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims

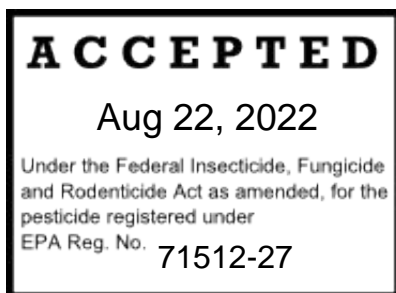

It is only to be used for formulation into end-use products registered for use on pome fruit (Crop Group 11-10); stone fruit (Crop Group 12-12); citrus fruit (Crop Group 10-10); tree nuts (Crop Group 14-12); low growing berry Subgroup 13-07G; bushberry Subgroup 13-07B; caneberry Subgroup 13-07A; fruit, small vine climbing (except grape) Subgroup 13-07E; fruit, small vine climbing (except fuzzy kiwifruit) Subgroup 13-07F; cucurbit vegetables (Crop Group 9); leafy vegetables (Crop Group 4-16); Brassica head and stem vegetables (Crop Group 5-16); fruiting vegetables (Crop Group 8-10); non-residential turf grass (including sod farms, golf courses and on non-residential non-crop lands); tuberous and corm vegetable Subgroup 1C; and indoor and outdoor non-food uses on non-residential ornamentals, conifers, Christmas trees and non-bearing fruit, nut and vines grown in commercial greenhouses, shadehouses and nurseries. This product may be used to formulate products for any additional uses not listed on this label if the formulator, user group, or grower has complied with USEPA data submission requirements regarding support of such uses.

### STORAGE AND DISPOSAL

---

**STORAGE:** Store in tightly closed original container, in a cool, dry (preferably locked) area that is separate from other pesticides, fertilizer, food, and feed.
