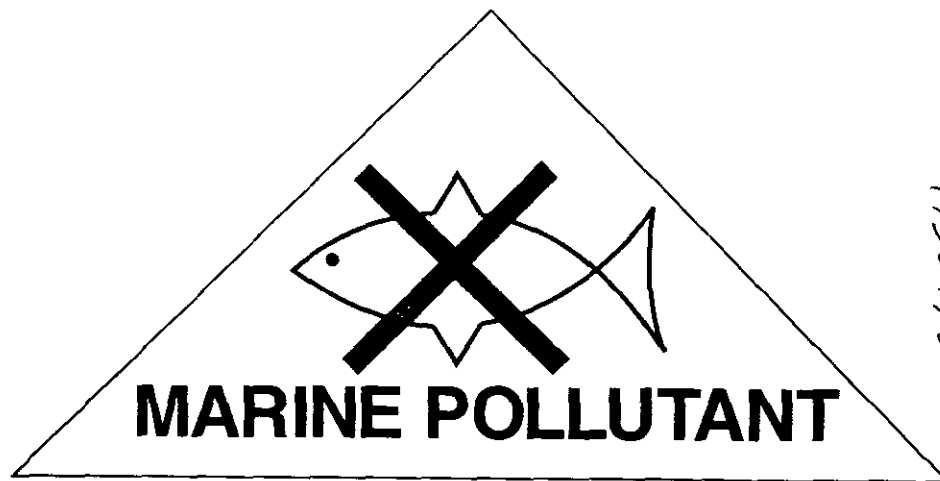

Storage and Disposal

STORAGE: Do not contaminate water, food, or feed by storage or disposal. In case of leak or spill, shut off or extinguish all sources of ignition. Shut off leak if without risk. Small spills, keep upwind. Large spills, evacuate area. If necessary to enter spill area, wear self-contained breathing apparatus and full protective clothing including boots. Sweep up or shovel into clean metal containers. Dispose of pesticide and container in accordance with instructions provided under DISPOSAL below.
