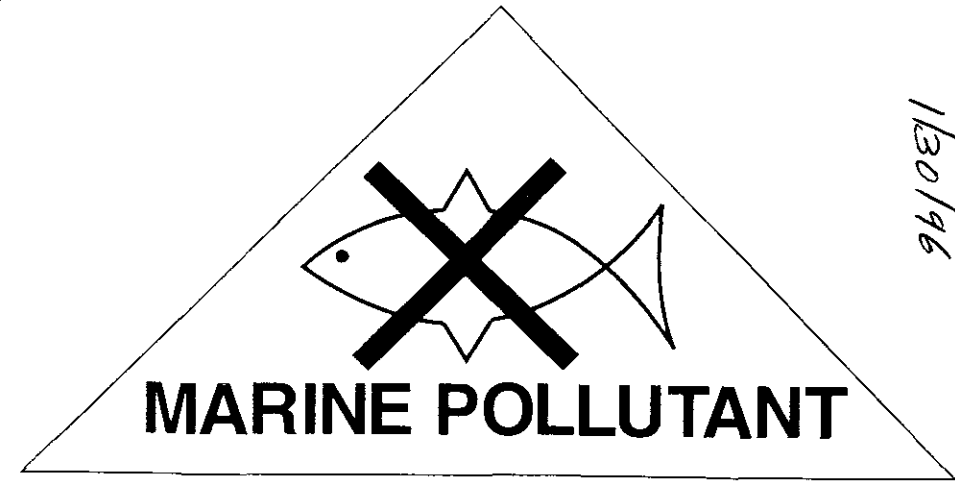
### Storage and Disposal
