### **DIRECTIONS FOR USE**

For use only in the manufacture of wood composites, Cobra™Crush MDT should be fed as a powder, prior to the curing stage, at the minimum rate of 0.4 kg per 100 kg to a maximum of 8.0 kg per 100 kg of adhesive binder and wood combined. Cobra™Crush MDT may be used to improve mould, fungal, insect and above ground service applications where there is limited exposure to rain and other sources of water. Industrial users of this product must be equipped to handle the powdered products using closed system application equipment i.e. screw feeder apparatus. Cobra™Crush is effective against some kinds of termites.

## STORAGE and DISPOSAL
