This amendment submitted in response to Agency letters dated October 16, 2001 and November 8, 2001, in which we requested that you remove Organic from the product name, add the phrase to empty to toilet bowl and delete the phrase "Made with Organic Acid Disinfectants".

The labeling submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments outlined below.

Labeling Requirements


1. You must list all organisms on the label by their complete **microbiological** nomenclature. The names of the organisms should not in be represented by all uppercase letters.
2. The claim for "Human Immunodeficiency Virus 1 (HIV-1)" should not appear on this label for a toilet bowl cleaner and was an oversight by the Agency. The claim for this pest in relationship to the use site is unacceptable. Please remove all information relating to HIV-1, everywhere it appears on this label.

TO CLEAN AND DISINFECT: To use, unscrew cap. Raise toilet seat. Remove bowl water. Aim directional spout under the bowl rim. Squeeze gently, directing at least 2 ounces of product (squeeze approximately 12 seconds) evenly around the rim of bowl. Do not dilute with water. Let stand for at least 10 minutes. Brush the entire bowl and flush. Replace cap. Rinse brush in fresh bowl water after each use. If bowl is heavily soiled, flush and remove excess dirt and grime before cleaning and disinfecting. Never use with chlorine bleach or any other chemical product.
