

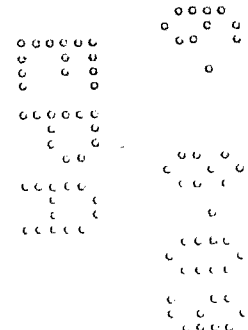

Squeeze gently, directing at least 2 ounces of product (Squeeze approximately 12 seconds) evenly to exposed surfaces below the rim of the bowl. Brush the entire bowl and flus. Replace cap. Rinse brush in fresh bowl water after each use

TO DISINFECT: Remove bowl water, by forcing through trap. Cover bowl surface with at least two ounces of product and let stand for at least 10 minutes. Do not dilute with water. Replace cap. Brush the bowl thoroughly and flush. Rinse brush in fresh water after each use.

If bowl is heavily soiled, flush and remove excess dirt and grime before cleaning and disinfecting. Never use with chlorine bleach or any other chemical product

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

PESTICIDE STORAGE: Store out of reach of children. Do not re-use empty container. Wrap empty bottle and put in trash or recycle.

CONTAINER DISPOSAL: Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke
