- c. Revise the statement "Removes the stains you see, kills the germs you don't!" to read "Removes the stains you see, kills the household germs you don't!"
- d. The product label must be revised to state that a pre-cleaning step is required before disinfection using this product. The stamped accepted label has been revised to comply with this requirement.
- e. Disinfection does not happen prior to pre-cleaning. Remove the phrase "Disinfects the surface as it cleans" from the label.
- f. The comparative claim phrase "Disinfects without harsh chemicals" is unacceptable and must be removed from the label.
- g. Correct the typographical error in the last sentence of "Warranty Statement" to read "... the manufacturer or seller **may** not be ..."

A copy of the stamped label has been enclosed for your records. Submit two copies of the revised final printed label for the Agency record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
