DIRECTIONS FOR USE

GENERAL INFORMATION

MONCUT® 50WP is a systemic fungicide for control of Southern stem rot (white mold) Sclerotium rolfsii, and the limb/pod rot complex, Rhizoctonia solani, in peanuts, and for control of sheath blight, Rhizoctonia solani, in rice.

MIXING DIRECTIONS

If this product is packaged in water-soluble bags, please read and observe the following directions for use:

- Packets containing MONCUT 50-W are water-soluble, Avoid exposing inner bags to moisture.
- Do not allow bags to become wet prior to adding to the spray tank.
- Do not handle inner bag with wet hands.
- Reseal outer bag in a manner that protects remaining packets from moisture.
- Turn on spray tank agitation prior to adding water-soluble packets.
- Consult the RECOMMENDATIONS section of this label to determine the number of packets you should use. With
 the tank agitation on, drop the required number of unopened packets into the spray tank while filling with water to the
 desired level (whenever possible direct the fill water over the top of the packets to increase the rate of package
 dissolution).
- Depending on the water temperature and the degree of agitation, the packets should be completely dissolved within approximately three to five minutes from the time they were added to the spray tank.
- Once the packets have completely dissolved, add other chemicals following conventional mixing order practices.
 (See section entitled COMPATIBILITY.)
- Tank-mix solutions containing boron will affect the solubility of the water-soluble film. Thoroughly rinse the spray tank of any boron containing spray solution prior to adding any water-soluble packets. When preparing tank mixes containing boron, add the correct amount of MONCUT 50-W to the spray tank first. Make sure that the water-soluble packets are completely dissolved. Add boron preparations to the spray tank last because even very low concentrations of boron will inhibit the solubility of the film. Carryover concentrations of boron in the spray tank need to be minimized and may cause dissolved water soluble bag material to precipitate and form insoluble residue in the spray tank system.

MIXING DIRECTIONS (continued)

If this product is <u>NOT</u> packaged in water-soluble bags, please read and observe the following directions for use:

- Buffer the water in the spray tank.
- Fill the spray tank ¾ full. Turn on spray tank agitation. Pour recommended amount of this material on the surface of water in the spary tank.
- Add balance of water to spray tank.
- Keep agitation running during filling and spraying operations.

USE PRECAUTIONS

Do not use oil as carrier or add other additives to the finished spray.

Do not plant rotational crops other than peanuts or rice for 12 months following the last application of Moncut 50WP, with the following exceptions:

- Corn, soybeans, or cotton may be planted 240 days or more following the last application of Moncut 50WP to peanuts.
- Soybeans or grain sorghum may be planted 240 days or more following the last application of Moncut 50WP to rice.

APPLICATION DIRECTIONS FOR PEANUTS

Apply Moncut 50WP as a broadcast foliar application using spray equipment commonly used to apply leafspot fungicide treatments. In fields with a history of high disease, or under prolonged conditions conducive to disease infection and development, higher labeled rates (2 lb/A or more) should be used for the most effective control. In such situations, sequential applications will provide more effective control than a single application. Moncut 50WP may be applied in tank-mix with leafspot treatments that fall within the recommended timing for Moncut 50WP application.

Moncut 50WP may be applied to peanuts through chemigation. (See application techniques below.)

Chemigation Application:

- Determine the size of the area to be treated.
- 2. Determine the time required to apply ¼ to ½ inch of water over the area to be treated when the system and injection equipment are operated at normal pressures as recommended by the equipment manufacturer.
- 3. Using water, determine the injection pump output when operated at normal line pressure.
- 4. Determine the amount of Moncut 50WP required to treat the area covered by the irrigation system.
- 5. Add the required amount of Moncut 50WP to the solution tank with sufficient water to meet the injection time requirements.
- 6. Make sure the system is fully charged with water before starting injection of the Moncut 50WP solution. Time the injection to last at least as long as it takes to bring the system to full pressure.
- 7. Maintain constant solution tank agitation during the entire injection period.
- 8. Stop injection equipment after treatment is completed. Continue to operate the system until the Moncut 50WP solution has cleared the last sprinkler head." (Also see "Application and Calibration Techniques for Sprinkler Irrigation" section below.)

Ground Application: By ground, apply recommended rate in 10-40 gallons of water per acre.

Aerial Application: By air, apply recommended rate in 5–10 gallons of water per acre.

Dosage Table for Peanuts

Diseases	Rate per Acre (lb./A)	Application Directions
Southern Stem Rot (white mold, Sclerotium rolfsii); Limb/Pod Rot Complex (Rhizoctonia solani)	2.0 – 4.0	One application program: Apply 2.0-4.0 lbs. Moncut 50WP per acre about 50-70 days after planting. Use the higher rates in fields known to have high disease incidence.
	1.0 – 2.0	Two application program: Apply 1.0-2.0 lbs. Moncut 50WP per acre. Apply 50-70 days after planting and repeat with a second application of 1.0-2.0 lbs. Moncut 50WP per acre about 30 days later. Use the higher rate in fields known to have high disease incidence.
	0.5 – 1.0	Four application program: Apply 0.5 – 1.0 lbs. Moncut 50WP per acre. Begin when conditions are favorable for soilborne disease development, generally 50-70 days after planting. Repeat application at 10 to 14 day intervals for a total of four applications.

- Apply no more than a combined total of 4.0 lbs. Moncut 50WP per acre to peanuts as a broadcast application during a single growing season.
- Do not apply later than 40 days prior to digging of peanuts.
- Do not feed hay or threshings from rotational crops of soybeans or cotton planted following the harvest of treated peanuts (more than 2.0 lbs. Moncut 50WP per acre), and do not allow cattle to graze soybean or cotton forage in these previously treated peanut fields.

APPLICATION DIRECTIONS FOR RICE

Apply Moncut 50 WP aerially in 5 - 10 gallons of water per acre, using one of the following schedules:

Dosage Table for Rice

Disease	Rate per Acre (lb./A)	Application Directions
Sheath Blight (Rhizoctonia solani)	0.7 – 1.0	Apply 0.7 – 1.0 lbs. Moncut 50WP per acre at first internode elongation, and follow with a second application at the same rate 10 to 14 days later. Use the higher rate where disease pressure is expected to be heavy.
	0.7 – 1.4	in fields where close scouting is practiced to detect and monitor sheath blight, apply Moncut 50WP when 5 – 10% of the tillers of a susceptible variety or 10 – 15% of a moderately susceptible variety have sheath blight lesions. Apply Moncut 50WP at 0.7 to 1.4 lbs. per acre. Continue scouting and reapply if disease begins to move up the rice stem again.

- Do not apply more than 2.0 pounds of Moncut 50WP per acre per year.
- Do not apply later than 30 days prior to rice harvest, or beyond 75% heading development stage, whichever
 occurs first.
- This pesticide is toxic to shrimp. Do not apply this product within three miles of any estuarine/marine waterways or watershed.
- Flooded fields may be used for aquaculture of crayfish only following rice harvest.

APPLICATION AND CALIBRATION TECHNIQUES FOR SPRINKLER IRRIGATION

Apply this product only through center pivot, motorized lateral move, traveling gun, solid set, or portable (wheel move, side roll, end tow, or hand move) irrigation system(s). Do not apply this product through any other type of irrigation system. Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers, or other experts.

Do not apply this product through irrigation systems connected to a public water system. 'Public water system' means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days per year.

Controls for both irrigation water and pesticide injection systems must be functionally interlocked, so as to automatically terminate pesticide injection when the irrigation water pump motor stops. A person knowledgeable of the irrigation system and responsible for its operation shall be present so as to discontinue pesticide injection and make necessary adjustments, should the need arise.

The irrigation water pipeline must be fitted with a functional, automatic, quick-closing check valve to prevent the flow of treated irrigation water back toward the water source. The pipeline must also be fitted with a vacuum relief valve and low pressure drain, located between the irrigation water pump and the check valve, to prevent back-siphoning of treated irrigation water into the water source.

Always inject this product into irrigation water after it discharges from the irrigation pump and after it passes through the check valve. Never inject pesticides into the intake line on the suction side of the pump.

Pesticide injection equipment must be fitted with a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump. Interlock this valve to the power system, so as to prevent fluid from being withdrawn from the chemical supply tank when the irrigation system is either automatically or manually turned off.

The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.

Spray mixture in the chemical supply tank must be agitated at all times, otherwise settling and uneven application may occur. Do not apply when wind speed favors drift beyond the area intended for treatment.

This product may be used through two basic types of sprinkler irrigation systems as outlined in Sections A and B below. Determine which type of system is in place, then refer to the appropriate directions provided for each type.

- A. Center Pivot, Motorized Lateral Move and Traveling Gun Irrigation Equipment
 - For injection of pesticides, these continuously moving systems must use a positive displacement injection pump, of either diaphragm or piston type, constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock and capable of injection at pressures approximately 2–3 times those encountered within the irrigation water line. Venturi applicator units cannot be used on these systems. Thoroughly mix recommended amount of this product for acreage to be covered into same amount of water used during calibration and inject into system continuously for one revolution or run. Mixture in the chemical supply tank must be continuously agitated during the injection run. Shut off injection equipment after one revolution or run, but continue to operate irrigation system until this product has been cleared from last sprinkler head.
- B. Solid Set and Portable (Wheel Move, Side Roll, End Tow, or Hand Move) Irrigation Equipment
 With stationary systems, an effectively designed in-line venturi applicator unit is preferred which is constructed of
 materials that are compatible with pesticides; however, a positive-displacement pump can also be used. Determine
 acreage covered by sprinkler. Fill tank of injection equipment with water and adjust flow to use contents over a thirty
 to forty-five minute period. Mix desired amount of this product for acreage to be covered with water so that the total
 mixture of this product plus water in the injection tank is equal to the quantity of water used during calibration, and
 operate entire system at normal pressures recommended by the manufacturer of injection equipment used, for
 amount of time established during calibration. Agitation is recommended. This product can be injected at the
 beginning or end of the irrigation cycle or as a separate application. Stop injection equipment after treatment is
 completed and continue to operate irrigation system until this product has been cleared from last sprinkler head.

ENDANGERED SPECIES

Restrictions in the State of Arkansas:

The use of MONCUT (flutolanil) on rice is restricted to protect the endangered fat pocketbook pearly mussel (*Potamilus capax*) and its habitat. Use is prohibited in the following areas of Arkansas:

Mississippi County: Within the basin that drains directly into the Right Hand Chute of Little River, south of Big Lake National Refuge.

Poinsett County: Between Crowley's Ridge and the levee east of the Right Hand Chute of Little River and the St. Francis Floodway. Use is also prohibited west of Rt. 140 and north of Rt. 63 at the SIPHON near Marked Tree. Except that the prohibited area does not include the area bounded by Arkansas Highway 373 on the west, Highway 63 on the east and Highway 14 on the south.

Cross, St. Francis, and Lee Counties: Between Crowley's Ridge and the levee east of the Right Hand Chute of Little River and the St. Francis Floodway as far south as the confluence of L'Anguille River (Lee County).
