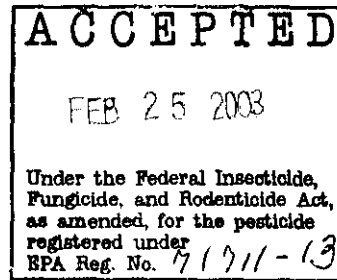

## **PRECAUTIONARY STATEMENTS**

### **HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

#### **CAUTION**

Causes moderate eye irritation. Harmful if absorbed through the skin. AVOID contact with eyes, skin, or clothing.

#### **Personal Protective Equipment (PPE)**

Some materials that are chemically resistant to this product are listed below. If you want more options for materials for gloves, follow the instructions for Category A on an EPA chemical-resistance category selection chart.

#### **Applicators and other handlers must wear:**

- Coveralls over long-sleeved shirt and long pants
- Chemical-resistant gloves made out of any waterproof material, such as polyethylene or barrier laminate
- Shoes plus socks

**AGRICULTURAL USE REQUIREMENTS**

**GENERAL INFORMATION**

PROSTAR 1.5G is a granular fertilizer impregnated with a systemic fungicide recommended for control of diseases of turf caused by Basidiomycetes. This product should be used for control of *Rhizoctonia* Brown Patch and has excellent safety on Kentucky bluegrass, creeping bentgrass, perennial ryegrass, red fescue, tall fescue, bermudagrass, St. Augustinegrass, and zoysiagrass.

**APPLICATION AND DOSAGE:** Apply the recommended amount of PROSTAR 1.5G per 1,000 square feet uniformly using a calibrated fertilizer spreader or other granular application equipment. Do not use this product at higher than the recommended rate.

**Irrigate the area within 24 hours after application to enhance dispersion of PROSTAR 1.5G and promote optimal performance.**

#### DOSAGE TABLE

#### **BROWN PATCH (*Rhizoctonia solani*):**

**Preventative:** Apply 4.0 to 6.25 lb. of PROSTAR 1.5G per 1000 square feet prior to initial signs of disease development. Repeat after a 14 to 30-day interval if conditions favor disease development.

**Curative:** Apply 6.25 lb. of PROSTAR 1.5G per 1000 square feet to turf with active Brown Patch. Make a second application 14 to 30 days later, if conditions favor disease development.

#### USE PRECAUTIONS

For use rates greater than 4.0 lb. PROSTAR 1.5G Fertilizer per 1000 square feet, do not apply within 100 feet of any estuary or marine habitat or within 100 feet of any ditches, drainage tiles, or other waterways that drain directly into (within one-half mile) estuaries or marine habitats. Apply no more than a combined total of 25 lb. of PROSTAR 1.5G per 1000 square feet (6.0 oz a.i./1000 sq. ft.) as a broadcast application during a single growing season.

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

**PESTICIDE STORAGE:** Store in a cool, dry location.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**CONTAINER DISPOSAL:** Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
