- a. Acute Neurotoxicity study (OPPTS Guideline No. 870.6200(a)) within 1 year of the date of this letter;
- b. Subchronic Neurotoxicity study (OPPTS Guideline No. 870-6200(b)) within 18 months of the date of this letter;
- c. Immunotoxicity study (OPPTS Guideline No. 870.7800) within 18 month of the date of this letter; and
- d. Developmental Thyroid study (Special Study) within 2 years of the date of this letter.
