

**How Do The Baits Work:**

Cockroaches live and breed where it is warm and dark and where there is access to food and food scraps. Small confined spaces are very attractive. Cockroaches are attracted to the CROAK Cockroach Baits. They enter, feed on the bait and most will return to their normal habitat to die. Others may die closer to the bait.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Place individual bait containers in the kitchen and other areas where cockroaches are likely to be found, such as the laundry and bathroom. Baits should be placed in warm dark areas – such as behind sinks, cupboards, refrigerators, stoves, hot water systems and washing machines. Place in areas inaccessible to children and pets. Avoid contamination of foodstuffs. Do not place baits where food is being prepared or on utensils that are used for food preparation.

Do not remove bait material from its individual container.
