Subject: Application dated September 26, 2003 for product Subtilex HB Biological Fungicide EPA Reg. No. 71840-4

Your application for amendment of the label amendment for the subject product is acceptable under the Federal Insecticide and Rodenticide Act, as amended (FIFRA). The revisions to the label are as follows:

• The FIRST AID section is revised as follows:

1) The section "If in eyes" is deleted, as it is not required.

2) The statement is added: "Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."

- In the PRECAUTIONARY STATEMENTS section, the first paragraph after the word CAUTION is deleted and the following statement is inserted: "Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals."
- In the DIRECTIONS FOR USE section under <u>FOR USE AS A HOPPER BOX</u> <u>TREATMENT FOR COTTON SEED</u> the reference to "inoculants" is made in the first and second sentences.

Please send to the Agency three (3) final printed labels before shipment.

AGRICULTURAL USE REQUIREMENTS

Use this product in accordance with its labeling and with the Worker Protection Standard, 40 CFR Part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions for exceptions pertaining to the statements in this labeling about PPE, restrictedentry intervals, and notification to workers. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard (WPS).

FOR USE AS A HOPPER BOX_TREATMENT FOR COTTON SEED

SUBTILEX[™] may be applied to dry seed or as a water-based slurry with other inoculants and registered seed treatment insecticides and fungicides. To mix, first add the inoculant / chemical insecticides and / or fungicides to the slurry mix with approximately ½ of the required water. Slowly add the SUBTILEX[™] to the slurry until a uniform suspension is obtained. Add the remainder of the required water and maintain continuous agitation. Do not store mixed slurries for longer than 72 hours.

APPLICATION RATE:

For suppression of *Rhizoctonia* and *Fusarium* seedling diseases, and *Fusarium* wilt, apply 4 ounces per 50 lbs. of seed.

CHEM:GATION

Do not apply this product through any type of irrigation system.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Do not contaminate water by cleaning of equipment or disposal wastes.

STORAGE: Store in a dry place.
