Because a picture of the appliance appears on the outer box (containing the appliance, butane cartridge and mats), we are adding this promotional language to the "Optional Selling Copy" section of the label; this will allow the logos and promotional tags to appear on the box itself, as stand alone copy or as a result of the appliance picture. We are also adding this Promotional Item Language to the appliance label section and the refills box.

The Wild Turkey Federal logo verbiage currently appears on our stamped accepted label; the additional promotional items particular to this notification include the Realtree logos (there are two) and the Realtree camo coloring of the appliance. Illustrations of these logos, etc. were submitted with the December 3, 2003 and November 15, 2005 submissions.


