This action is taken under the authority of section 4(g)(2)(c) of FIFRA, as amended. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. EPA may require submission of data at any time to maintain the registration of your product.

For the purpose of this Notice the last stamped accepted label dated July 5, 2017 has incorporated the required mitigation language for the d-Allethrin RED, therefore no additional labeling is required.
