As you might recall, our **SHERP**-**SHIELD** product brand of calcium hypochlorite is used for the destruction of microbes associated with medical waste and it is strictly a "repack". We wish to change the quantity of the product we sell per package from 125 to 50 grams.

The container size has not changed; neither have the directions for activation, as described on the Solidification Compound label. The quantity of chemicals in the Solidification Compound container has not change, thus not creating a need to change the amount of water used.

We are submitting, for your approval, a new label showing a smaller quantity of the product sold in the package. That is the only change on the previously approved label. A copy with the change highlighted in yellow is enclosed along with five copies of the labels.
