GENERAL PRECAUTIONS FOR APPLICATIONS THROUGH SPRINKLER IRRIGATION SYSTEMS

Maintain continuous agitation in mix tank during mixing and application to assure solution uniformity. The irrigation system must contain a functional check valve, vacuum relief valve and low-pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back towards the injection pump. The pesticide injection pipeline must also contain a functional, normally closed solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when irrigation system is either automatically or manually shut down. Do not apply when wind speed favors drift, when system connection or fittings leak, when nozzles do not provide uniform distribution or when lines containing the product must be dismantled and drained.
