### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

### HOW TO APPLY

- Adjust nozzle to coarse spray.
- After weeds have emerged spray the weeds AND the entire surrounding area you want to keep free of weeds for up to 3 months. Spray the area until THOROUGHLY WET.
- When spraying around the base of well-established ornamental plants, shrubs or trees, shield desirable plants from drift with a sheet of cardboard or plastic. If desirable plant is accidentally sprayed, rinse off immediately with water.
- For best results, apply during warm, sunny weather (above 60 F).
