The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable. The revised basic csf and alternate csf #1, both dated 8-13-12, are acceptable and will replace the previously accepted basic csf and alternate csf #1.

Please note, "NEW" and "NOW" may only remain on the label for a period of 6 months.

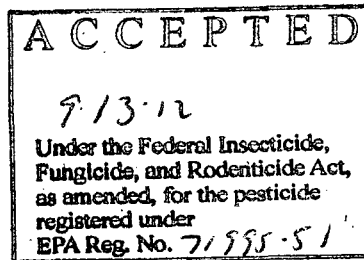

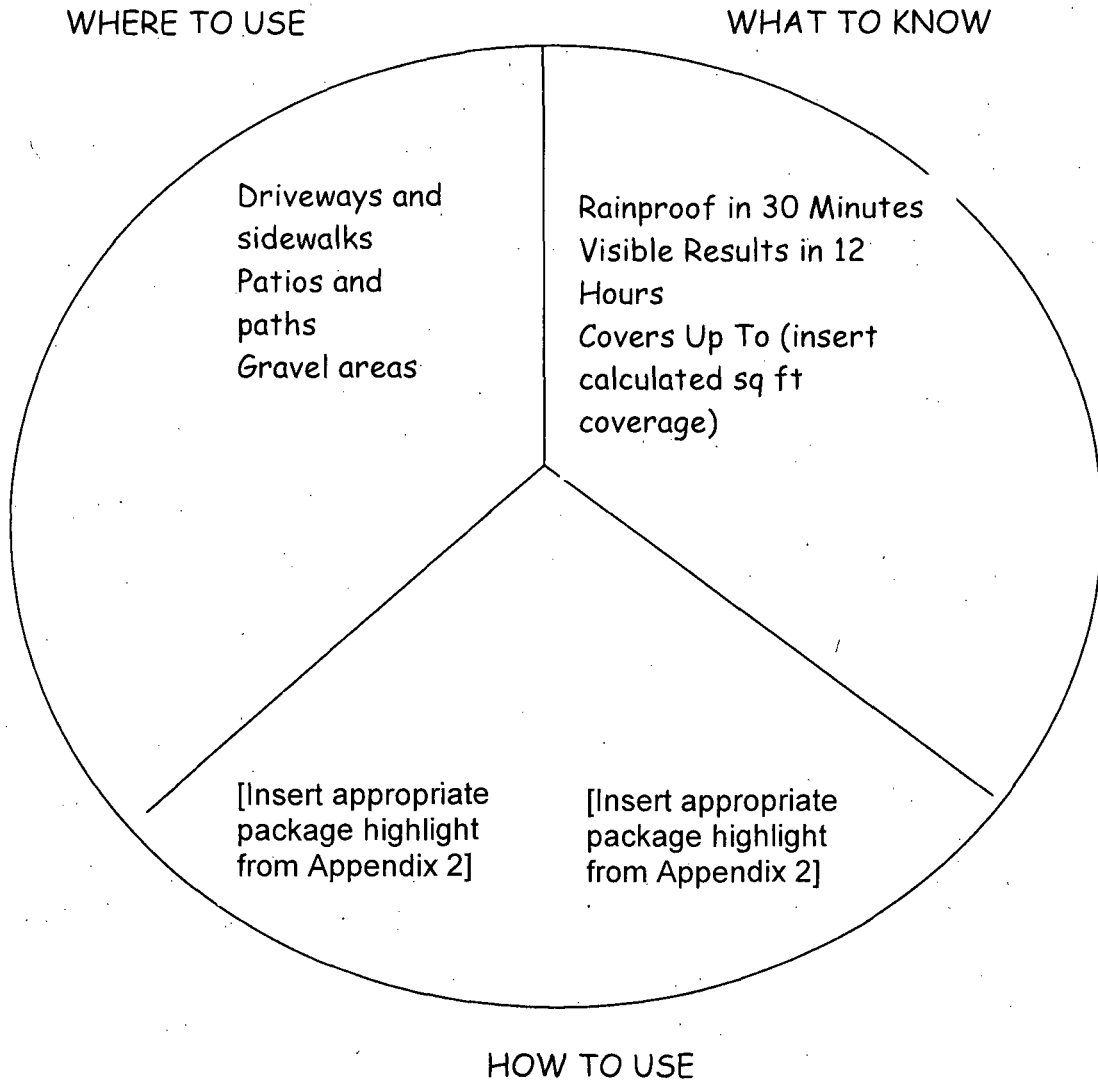

Possible Cause: Product supply is low
Solution: Refill container with product
