The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable.

This approval does not affect any terms or conditions that were previously imposed on this registration. You continue to be subject to existing terms or conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one (1) copy of the final printed labeling before you release this product for shipment with the new labeling. In accordance with 40 CFR § 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

Should you wish to add/retain a reference to your company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the U.S. Environmental Protection Agency (EPA). If the website is false or misleading, the product will be considered to be misbranded and sale or distribution of the product is unlawful under FIFRA section 12(a)(1)(E). 40 CFR § 156.10(a)(5) lists examples of statements the EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration

- 1) Shake well before each use. [Alternate Statement for Drums and Totes (greater than 50gal): Mix well before each use.]
- 2) Add 16 fluid ounces of product for each gallon of water and thoroughly mix.
- **3)** With garden sprayer or sprinkler, apply diluted product liberally to lawns or turf areas during a dry period. Re-apply as needed. [**For best results**, apply early in the season, prior to laying of eggs and/or nesting on property.]

Commercial Use Mix/Spread Rate:

- -16 fluid ounces per gallon of water

[Option 2: Liquid Fence Ready-to-Spray Directions]

- 1. Shake well before each use.
- 2. Make sure the control knob is in the off position. Attach and hand tighten water-hose to nozzle. Turn water on at faucet, aim nozzle toward area you wish to protect. Remove safety tab from nozzle by pressing towards control knob, snapping it off. Turn the control knob to the ON position to begin spraying.
- 3. Apply **Liquid Fence Goose Repellent** liberally to lawns or turf areas during a dry period.
- 4. When finished, turn the control knob to the off position. Turn faucet to off position. Discharge residual water pressure by turning control knob to water position and then off again. If you desire to spray water only, turn the control knob to the water position, to bypass the product.

[Option 3: Hose End Sprayer Directions]

- 1. Shake container well before using.
- 2. Connect a garden hose to the Ready Spray nozzle. Make sure the dial on the nozzle is in the "OFF" position with the [green] safety tab in the valve notch.
- 3. Turn on water at faucet. Extend hose to the farthest area to be treated and work back toward the faucet so you don't come in contact with the treated area.
- 4. To BEGIN spraying, point nozzle toward treatment site and a.) bend the [green] safety tab back (located at right of yellow dial) with your thumb, b.) hold while turning yellow dial clockwise until it stops. Water will automatically mix with the product.
- Spray until wet. Walk at a steady pace while spraying using an even sweeping motion, slightly overlapping treated areas.
- 6. To STOP spraying, QUICKLY turn the dial counter clockwise until it stops and the safety tab engages into the notch on the valve. Turn water off at faucet. To relieve pressure before removing nozzle from hose, bend the safety tab back and turn dial "ON" until water stops spraying.
- 7. To STORE unused product, make sure the dial is in the "OFF" position with [green] safety tab in the valve notch. Place in cool area away from heat, sunlight or open flame.]

[Option 4: Hose End Sprayer Directions]

- 1. Shake container well before using.
- 2. Connect a garden hose to the Ready Spray nozzle. Make sure lever is fully forward in the "OFF".
- 3. Turn on water at faucet. Extend hose to the farthest area to be treated and work back toward the faucet so you don't come in contact with the treated area.
- **4.** To BEGIN spraying, point nozzle toward treatment site and pull lever backwards towards hose connection. Water will automatically mix with the product.
- 5. Spray until wet. Walk at a steady pace working back towards the faucet while spraying using an even sweeping motion, slightly overlapping treated areas.
- **6.** To STOP spraying, push lever forward toward nozzle until water flow stops. Turn water off at faucet. To relieve pressure before removing nozzle from hose, pull lever backwards towards hose connection until water stops spraying.
