Enclosed is EPA Form 8570-1 with notification to the Agency of additional of similar application methods added to the registered label of EPA Reg. No. 72083-1, SeaKlear Algae Prevention and Remover.

The new application method conforms with the provisions of FIFRA §2(ee)(3) by allowing no greater exposure than the exposure of the currently registered method and allowing no change in dosage, concentration, timing or frequency of application of the registered product. The registered product is not for use against public health organisms or termites.

The new application method is added to the Direction for Use under direction number six and states the following: "6. When applicable, pierce dots on pill where indicated with enclosed pin. With filter running, place pill directly into pool skimmer."

This use instruction is being added to the label in support of a supplemental distributor's product, EPA Reg. No. 72083-1-41547. The supplemental distributor's product, 90-Day-Plus Algaecide by Smartpool, is distributed in single application packaging called a "pill." One "pill" equates to one 3 month dose of the algaecide. The packaging requires the above use instruction for the different application method explained in the instruction. Although the packaging and instruction number six are different, the remainder of the label remains the same as the primary registration.

Also note that the SeaKlear Algae Prevention and Remover label, 72083-1, will continue to be distributed without use instruction number six, as it does not apply to the Seaklear Algae Prevention and Remover application method as sold by HaloSource.

Please find enclosed, three copies of the primary registration label with additional application method highlighted, three copies of the primary registration label as distributed and sold, and three copies of the supplemental distributor's label with the added instruction.
