3. Delete the last sentence of the product description, "The cartridge inhibits bacterial re-contamination and keeps water fresh for storage by inhibiting bacterial fouling", as this is too broad a claim.
4. Add "eye" to the end of the eye treatment instructions in the First Aid statement.
5. Add a batch code, or other identifying code, on the label or on the immediate container itself, but it must appear on each individual container. It may not appear only on overwrap or a secondary container such as a cardboard box that could be separated from the container and thrown away.

Submit one copy of the finished final printed label prior to releasing this product for sale.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e).

The HaloPure Bacteriostatic Pitcher Cartridge is a bacteriostatic water treatment cartridge for use in point-of-use drinking water pitchers. The Cartridge is only for use in drinking water pitchers that treat potable water or municipal water treated in accordance with the Safe Drinking Water Act. The product is not designed to treat salt water, waste water, or raw, untreated water, and is not a drinking water purifier.

The Cartridge removes objectionable tastes and odors from drinking water. The Cartridge inhibits spoilage and the growth of odor-causing bacteria in the Cartridge to prolong the life of the filter. The Cartridge inhibits the growth of non-public health bacteria within the water Cartridge and reservoir. ~~The Cartridge inhibits bacterial re-contamination and keeps water fresh for storage by inhibiting bacterial fouling.~~ delete

The HaloPure cartridge will keep water fresh in the water storage reservoir and inhibit bacterial fouling of the container. The cartridge is effective through 400L, after which time the cartridge must be replaced.

**STORAGE AND DISPOSAL**

Do not contaminate water, food or feed by storage or disposal. Wastes resulting from the use of this product must be disposed of onsite or at an approved waste disposal facility.
