Dear Ms. Johnston:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

- 1. Make the following changes to the STORAGE AND DISPOSAL section to comply with PR Notice 2001-6:
  - Delete the "PESTICIDES DISPOSAL" section ("Wastes resulting from the use of this product may be disposed of .....").
  - Revise the "CONTAINER DISPOSAL" heading to read simply "DISPOSAL".
  - Delete the statement "If burning stay out of smoke."
- 2. Revise the last sentence of the FIRST AID section to read: "Have the product container or label with you when calling a poison control center or doctor or going for treatment."
