### **CLEANING / DEODORIZING:**

General Cleaning: Use this product for general household cleaning and removing grease.

**Toilet Bowls:** Dilute 1/4 cup (2 FL OZ) per 1/2 gallon of water and add to toilet bowl, brush thoroughly.

Laundry: Use 1 cup (8 FL OZ) per medium load with your regular detergent to improve washing.

Carpet Spot Cleaning: Dilute 1/4 cup (2 FL OZ) of this product in 1 gallon of water. Use clean rag or sponge to clean small area of the carpet. Always test a small, hidden area of the carpet to check color fastness first.

DISINFECTING: To kill gram negative bacteria in toilet, sickroom and other hard, non-porous, non-food household surfaces such as floors, walls & tubs (includes pet sleeping areas & garbage pails): All surfaces must be precleaned prior to disinfecting. Use 1 1/3 cups of product (10.5 FL OZ) per ½ gallon of water [or Use 2/3 cup (5.25 FL OZ) per ½ gallon of water]. Apply solution with sponge, mop or cloth and thoroughly wet all surfaces. Let stand 10 minutes. Prepare a fresh solution for each use.

### FIRST AID:

### If in eyes:

- Hold eye open and rinse slowly and gently with water for 15 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
- Call a poison control center or doctor for treatment advice.

### If swallowed:

- Call a poison control center or doctor immediately for treatment advice.
- Have person sip a glass of water if able to swallow.
- Do not induce vomiting unless told to do so by the poison control center or doctor.
- Do not give anything by mouth to an unconscious person.

Have the product container or label with you when calling a poison control center or doctor or going for treatment.
