2. Submit the storage stability data (EPA Guidelines Number 830.6317 and Corrosion Characteristic (EPA Guidelines Number 830.6320 within one year from the date of this Notice of Registration. This requirement was stated in the Product Chemistry Review that was enclosed with this Agency's letter dated April 2, 2003.
3. Add the statement: "Contains Nitrosoamine" to the ingredient statement on the enclosed stamped label.
4. Submit a revised Confidential Statement of Formula (CSF) on EPA Form 8570-4 to reflect the statement at end of formula that reads: "contains a maximum of 0.00022 ppm nitrosamine".
5. Submit one (1) copy of the final printed labeling before you release this product for shipment.

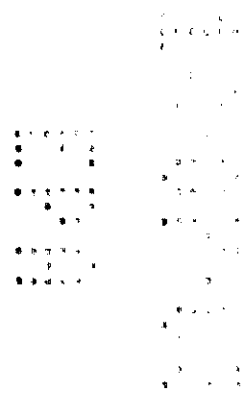

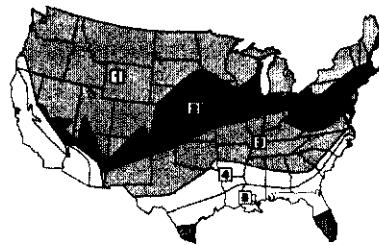

FOR BEST RESULTS

- Apply this product before the crabgrass germination date noted below for your area. Apply before March in California.

Approx. Date

- 1 – After May 30
- 2 – After May 10
- 3 – After April 20
- 4 – After March 20
- 5 – Jan. 1 to March 20



[Certain plant stages can be used to help properly time application, e.g., during forsythia bloom or just before dandelions reach puffball stage.]

- Make sure lawn receives at least ½" of water within 14 days after application, either from rain and/or sprinkling.
- A second application may be necessary in areas where there was a lot of crabgrass the year before or where there is a long growing season. Make second application 6 – 8 weeks later.
- Seeding**
 - Do not apply to overseeded turf for 4 months after seeding or until the second mowing, whichever is longer.
 - Do not overseed for 4 months after using this product.
- Sodding** – Do not apply to newly set sod.
- Sprigging or Plugging** – Stolen rooting of newly sprigged or plugged grass may be temporarily slowed.
