- 2. The following claims are unsubstantiated and therefore, must be removed from the proposed label otherwise, data mst be submitted to support these claims.
 - Preventative maintenance against roaches
 - Keeps roaches out of sight
 - Destroys entire nest/colony
 - Even attractive to roaches up to 24 months after application
 - Stays moist and attractive for months
 - Overnight results
 - Remove the word "Innovative" from the claims that continues with fast-acting formula that quickly kills roaches
 - Starts killing in hours and keeps on killing.

There is no objection to the quick claims based on 24 hour 31-40% mortality for the imidacloprid baits. Further, there is no objection to six months control claim. The following wording should be included everywhere the claim is made on the labeling in order to communicate to the user that the product will only remain efficacious for six months if there is bait still left in the station.

- "Up to six 6 months protection or until bait is fully consumed, and even attractive to roaches up to 6 months or until bait is fully consumed."


