 - "Just one application quickly kills insects --Continues killing for up to 12 months (1 year) indoors."

These claims must be deleted or revised as follows:

- "Indoor protection for up to 12 months (1 year) for German cockroaches, black carpenter ants, and house crickets on non-porous surfaces."
- "Up to 12 months (1 year) Indoor Protection for German cockroaches, black carpenter ants and house crickets on non-porous surfaces."
- "Just one application quickly kills insects-Continues killing German cockroaches, black carpenter ants, and house crickets up to 12 months (1 year) indoors on non-porous surfaces."
- g) Remove "diseases" and "bacteria" throughout the label. Claims implying that the product is capable of disease control are not acceptable.
- h) The submitted efficacy data support the use of this product as a sanitizer against Staphylococcus aureus and Enterobacter aerogenes on hard, non-porous, non-food contact surfaces in the absence of organic soil for a contact time of 5 minutes. Include use directions for the sanitizer application. Included in the directions for use must be the organisms for which efficacy has been demonstrated, contact time and representative contact surfaces. Therefore revise the label as follows:
 - 1) Add a single asterisk above the word "germs" throughout the label. Under Kills, replace "(plus reduces germs)" with "*Reduces 99.9% of *Staphylococcus aureus* and *Enterobacter aerogenes* on hard, non-porous, non-food contact surfaces. No residual sanitizer action. Not for primary use as a sanitizer."
 - 2) Under Where to Use add "only" to the statement "Indoor as a spot or crack and crevice spray only."
 - 3) Under How to Use second bullet add, "Allow surfaces to remain wet for at least 5 minutes. Do not apply as a broadcast spray."

Please refer to the enclosed efficacy review memos (Blackburn, 4/23/2007; Sweeney, 6/6/2007) for details concerning labeling claims.

- i) Under Environmental Hazards delete the 2nd bullet, "...equipment washwaters or rinsate." This is a ready to use spray product so this statement does not apply as there should be no "equipment washwaters".
- j) Move that last 2 bullets under Environmental Hazards to the Directions for Use section of the label.
- k) Under Precautionary Statements revise the 2nd bullet to read, "Causes moderate eye irritation." Also, revise the 4th bullet by adding the following at the end of the sentence, "... and before eating, drinking, chewing gum, or using tobacco."
- 1) Add a double asterisk above Termites on pg 4 and under Wood Infesting Pests on pg 3.

- 3. The CSF for the basic formulation dated 11/01/06 is acceptable. However, we request that a revised copy is submitted with the correct spelling of the chemical name for the AI Preventol: "sodium ophenylphenate". A copy of the CSF has been placed in the file for the subject product.
- 4. Product Chemistry data requirements for the 830 Series Subgroup A and Subgroup B guidelines are satisfied, except for storage stability (830.6317) and corrosion characteristics (830.6320) data. These data are outstanding and must be submitted to satisfy the requirements of 40CFR 158.190.
- 5. The acute toxicity data submitted to support this registration have been reviewed and classified as acceptable. A copy of the review memo is enclosed for your records. The acute toxicity profile of the product has been determined to be as follows:

Acute Oral -----IIIPrimary Eye Irritation ----- IIIAcute Dermal --- IVPrimary Dermal Irritation --- IVAcute Inhalation --- IVSkin Sensitization ----- Negative

6. Submit three (3) copies of your revised labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.


