- 2. You must submit the following conditional data before the due date of 11/1/2010:
  - a. Storage Stability (830.6317) and Corrosion Characteristics (830.6320) studies.
- 3. Make the following changes to the label:
  - a. Change the product registration number to "EPA Reg. No. 72155-93"
  - b. On pages 1, 2, and 6 the label must state "Intended for Homeowner Use Only."
  - c. On pages 1, 2, and 6 please make the following deletions and/or revisions to the bulleted marketing claims:
    - 1. Delete "Rainproof Protection" as it implies protection from being rainproof, and that the product is not rainproof.
    - 2. Delete protects 24/7 as this is a marketing claim.
    - 3. Delete "Internal protection will not wash off." The statement is repetitive.

  - d. On pages 1 and 2, change the first bulleted line to read "One quart treats 5,000 square feet."
  - e. On pages 1 and 2, change "Net Contents:" to "Net Contents: 32 fl. oz."
  - f. If you wish you may delete the signal word **CAUTION** from pages 1, 2, and 6. In accordance to the Acute Toxicity review, it is not required.
  - g. On page 3, in the section **COVERAGE**, change the second bulleted line to read "32 fl. oz. size treats 5,000 sq. ft."


