BEANS, DRY	Rust (Phakopsora spp.)	1.25-1.8 lbs.	7.2	Use in sufficient water to obtain adequate coverage. For rust, apply at first sign of disease and retreat on a 7-14 day schedule. For resistance management of rust, alternate with another fungicide registered for bean rust control. For use only on beans to be harvested dry with pods removed. DO NOT apply more than four times per growing season. DO NOT apply within 14 days of harvest. DO NOT allow livestock to graze in treated areas or feed treated plant parts to livestock. Equus DF may be applied through sprinkler irrigation equipment. See calibration directions which appear on the product label.
SOYBEANS (Determinate and Indeterminate Varieties)	Rust (Phakopsora spp.)	1.25 - 2.2 lbs.	7.2	Apply in sufficient water to obtain complete coverage, generally 10-20 gallons per acre. Make first application at first sign of disease and retreat at 14-day intervals. For resistance management of rust, alternate with another fungicide registered for soybean rust control. DO NOT exceed a total of 3 applications per season. DO NOT apply within 6 weeks of harvest. DO NOT feed treated parts to livestock or allow grazing in treated fields.
